

~ Resolution Creation of Executive Director of Canteen, AMVETS Post 17 ~

Title: Resolution to Amend current Bar Manager Title to Executive Director AMVETS Post #17

Proposed: 08 JUN 2026

Whereas, AMVETS Posts are chartered to support veterans, their families, and the community through programs, events, and facility operations; and

Whereas, AMVETS Post #17, Easton PA operates wholly as a non-profit entity; The Post Canteen operates in support and furtherance of same; and

Whereas, to align to standards within the **non-profit** realms locally and globally; and

Whereas, Post Canteen Manager has been instrumental in the smooth operations of and well-being of not only the Canteen but AMVETS Post #17 as a whole for several year; and

Whereas, The participation of the **Commander** and **Vice-Commander** are solely contingent of The **Canteen Manager** remaining an integral part of the *Post Canteen* and AMVETS Post #17 as a whole; and

Whereas, A separate resolution will be presented to request the Executive Director to be present at, and participate in a non-voting roll at the Board of Directors Executive sessions.

Now, therefore, be it proposed, that AMVETS Post #17 hereby adopts a title change of *Canteen Manager* that applies to the current *Canteen Manager* as of the date 09 JUN 2026 exclusively; and

Be it further proposed, that the compensation for this role does not change due to any portion of this matter; other than allowed by fulfilling of official duties, as such the *Executive Director* be properly, and legally compensated for his time in furtherance of the role of *Executive Director*; in accordance with all applicable **Laws, Constitutions, and By-Laws**; and

Be it further proposed, At such time as the current Canteen Manager were to vacate his role and responsibilities at the Post, the position of Canteen Manager shall be filled by a qualified candidate, without the benefits outlined herein; and

Be it further proposed, the current and proposed role is employment "At-Will", governed by all applicable employment laws; and

Be it further proposed, that the Post shall notify all current **Active (Veteran) Members** and **Social Members** of this change in accordance with Post bylaws and standard communication practices by posting for not less than 60 days.

Be it finally proposed, that AMVETS Post #17 hereby adopts a title change of the current *Canteen Manager*, exclusively, to **Executive Director AMVETS Post #17 & Canteen**; and that Mr. David Starr be designated as the **AMVETS Post #17 Executive Director** to fulfill duties at the discretion of the *Board of Directors* and in accordance with National and Local Post Constitution and National and Local Post By-Laws.
